

**Agreement of cooperation between
Chinese Wushu Association (CWA)
and
Russian Wushu Federation (RWF)
regarding Wushu Duanwei System promotion**

Cooperation content and implementation

Under the principle of trust and respect for each other, CWA and RWF will cooperate to launch and spread the Chinese Wushu Duanwei System (CWDS) in Russia. To guarantee a smooth and sustainable development, both sides have agreed on the following after friendly consultations:

-CWA approve that RWF establishes a test center of CWDS in Russia.

-The "Textbook Series of Chinese Wushu Duanwei System" is the content basis for the RWF to develop Duanwei training and examination. The RWF will develop the Duanwei System according to its national situation. The CWA will provide RWF with corresponding support and help. The CWA and RWF will jointly conduct training and qualification verification on the Duanwei trainers and evaluation staff. The related expenses shall be borne by the RWF.

-RWF itself can organize training, test and assessment up to 3rd Duan. For this purpose RWF must establish a Wushu Duanwei System Committee for examination and assessment purposes that includes at least three Wushu professionals with the qualification of 4th Duan to 6th Duan. Further, RWF shall establish a Wushu Duanwei System Office, which will be responsible for examinations, assessments and judgment of Wushu practitioners, and submit name lists and examination video reports to CWA. The successful participants shall be issued with CWDS certificate and badge after approved by CWA.

- 4th Duan to 6th Duan examination and assessment of CWDS can be organized and implemented by RWF. The qualified trainers and evaluation staff will implement the training and examination. The expert team of CWA composed of 1-3 persons will monitor and verify the whole process of examination. The related expenses shall be borne by the RWF. Every participant who successfully completes the training and pass the examination and assessment shall be issued with the corresponding Wushu Duan certificate and badge.
The RWF will issue and sign the certificates.

- Russian nationals shall (1-6th Duan) pass the examination of Duanwei in Russia only. Those who have got the Chinese Residence Permit can take the examination in China. In this case, in order to be recognized in Russia, they shall provide a copy of the CWA official video recording of the examination and a letter of support of the CWA.

-Examination and assessment of Wushu 7th Duan to 9th duan can only be organized and implemented in China by CWA. RWF can recommend the qualified practitioners to apply for higher Wushu Duanwei, but the practitioners have to go to China to attend training courses and examinations.

-RWF should charge fees according to standards announced by CWA for oversea persons applying to obtain Wushu Duanwei accreditation and forward these set fees to CWA.

RWF can further charge relevant fees (registration, training and examination fees, etc.) from the participants in order to cover costs organization Wushu Duanwei training, examinations and inviting Chinese expert team. To cover costs which RWF alone is responsible for, RWF can decide the level of the fees by itself.

Cooperation Period and Notes

-This cooperation project will start in 2014 and will continue in a long term.

-This agreement will be effective from the day both sides sign it. The agreement will be effective for a period of five years. It will extend another five years automatically if either side does not terminate the agreement.

-If difficulties and problems arise during the cooperation, both sides should try their best to solve them in a friendly manner.

Termination Clause

CWA and RWF will actively and friendly start cooperation on the basis of trust and respect for one another. Both sides are willing to cooperate in long term and try their best to spread Chinese Wushu in Russia.

If either the CWA or RWF for unforeseen reasons would like to end the cooperation, this can be done with a written 6 months' notice.
